(*Lifting Device Inspection: required annually under OHSA).

PRE-REQUISITES

Instructor candidates must be competent on all EWP types specific to your operation, possess effective communication and directional skills and be Working at Height certified specific to your sector.

COMPLIANCE

- i. CSA Standards: *B354:17 Mobile Elevating Work Platforms*, require that only qualified personnel who have been trained regarding the inspection, operation, and application of an aerial platform, including the recognition and avoidance of hazards associated with the operation, shall operate an aerial platform.
- ii. Safe-Tech programs meet or exceed all relevant CSA Standards, applicable Federal/Provincial regulations and Ministry of Labour Guidelines.
