The **Safe-Tech Working at Heights Refresher Program** meets or exceeds all requirements of the **new** Working at Height Refresher Guideline and is applicable for workers who were previously certified by a CPO approved training provider. Participants must provide **proof of completion of prior training**. This can include the CPO-issued card or the completion card issued by the approved training provider. The Chief Prevention Office will not issue a Refresher record of training to a learner who has not previously completed a CPO approved program.

Refresher training mandatory every 3 yrs for worker to maintain certification validity.

Program is in compliance with Ontario regulation 213/91 section 26 of the Construction regs and meets or exceeds all requirements of the new Working at Heights Refresher Guideline.
